


Lesson Agencies for Prevention and Control of Communicable Diseases

REPUBLIC ACT 3573

This is an Act requires all individuals and health facilities to report notifiable diseases to national and health authorities. It is otherwise known as "An Act Providing for the Prevention and Suppression of Dangerous Communicable Diseases and for other Purposes".


What is It

There are agencies and institutions of the government that support the relational efforts in promoting health, prevention and control of communicable diseases. The agencies are shown in the grid below.

AGENCY	DESCRIPTION	ROLES	
Department of Health (DOH)	• This is the principal health agency in the Philippines. It is responsible for ensuring access to basic public health services to all Filipinos through the provision of quality health care and regulation providers of health goods and services.	• To formulate, promote and implement programs to ensure preparedness and response in anticipation to negative consequences that may result in pandemic proportions of diseases	
Department of Education (DepEd)	• This is a government agency responsible for the formulation, implementation, and coordination of policies, plans, programs, and projects in the areas of formal and non-formal basic education.	To promote and provide Filipino learners with sustainable holistic school health programs and the control and prevention of communicable diseases toward healthier behavior and better learning outcomes	

Department of Social Welfare and Development (DSWD)	• This is a government agency which is ordered to enhance, apply, and coordinate social protection and poverty reduction solutions for and with the poor, vulnerable, and disadvantaged.	 To activate the community health providers to give comprehensive public health services To provide information drive and assistance to all Filipinos
Department of Interior and Local Government (DILG)	• This is an executive department liable for sustaining peace and order, securing public safety and strengthening the capability of local government units to effectively and efficiently deliver basic services to the citizenry.	• To assist LGUs to effectively and efficiently deliver services to their people
Disease Prevention and Control Bureau (DPCB)	• This is an agency that works to lead and align all efforts in the prevention and control of diseases to achieve healthy communities by having good governance, active partnership, and shared values.	 To enhance policies, program designs, and projects in order to prevent and control the spread of diseases and maintain health protection To provide coordination, technical assistance, capability building, and advisory services in connection to prevention and control of diseases and health protection sustainability.

Inter-Agency Task Force (IATF)	• is a task force organized by the executive of the Philippine government to respond to affairs concerning emerging infectious diseases in the Philippines.	• This agency was organized as government's instrument to assess, monitor, contain, control, and prevent the spread of any potential epidemic in the Philippines.


