

REMEMBER

To determine the relevance and truthfulness of an idea presented especially from the media, we assume that everything is true. In this lesson, determining the relevance and truthfulness needs to be scrutinized and examined. Here are some of the basic aspects to consider in identifying relevance and truth of the ideas presented from the material viewed; (a) fallacy, (b) fact, (c) opinion, and (bias)

- a. Fallacy it is an idea which is believed to be true but it is really false due to incorrect information or reasoning.
- b. Fact is an idea which is true and can be verified factually or proven.
- c. Opinion is an idea or statement which only comes from someone's feelings and cannot be proven.
- d. Bias it is an idea that leads to poor judgment and poor decision making towards a certain thing for it could be positive one in favor of a certain person and negative for the other one.




