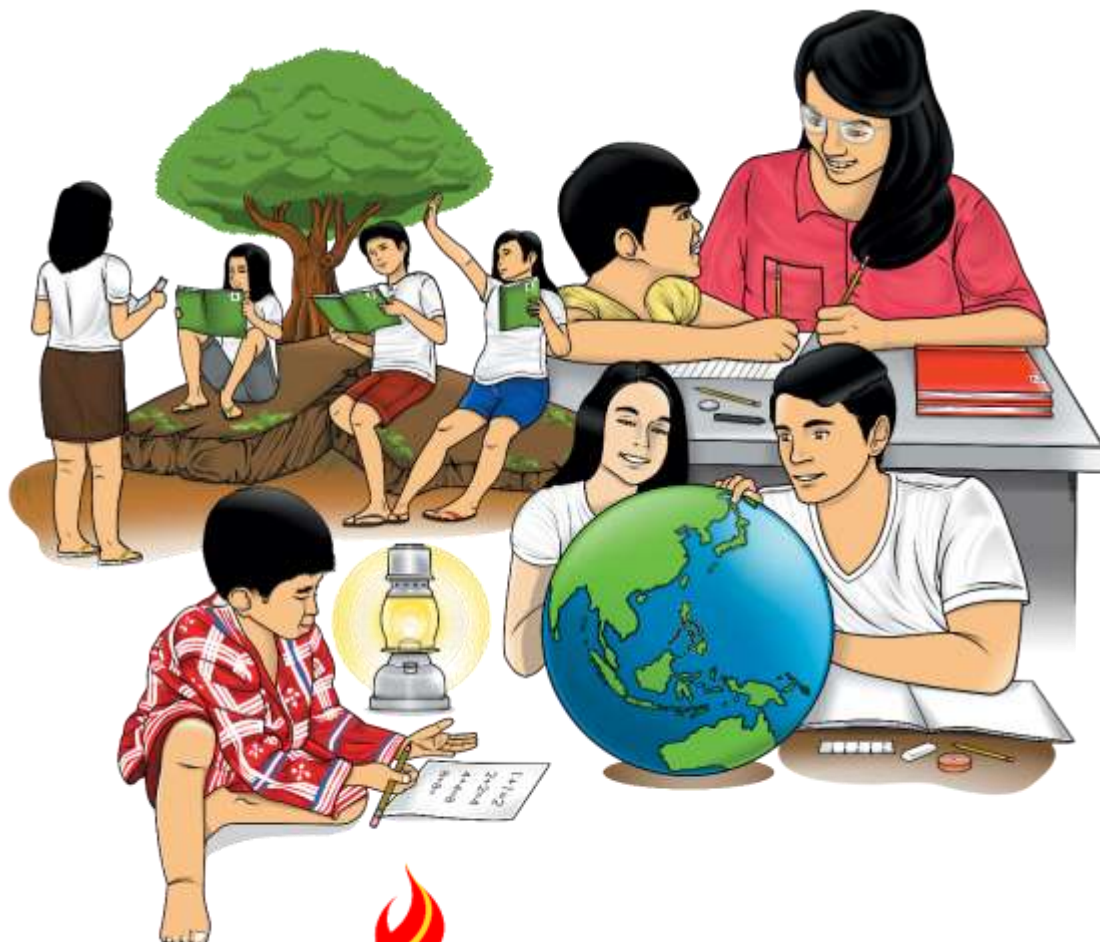

What Is It

We defined it!!!

- **Extortion**

An act or practice of obtaining or extorting money, property to someone forcefully or by threats. The extortionist may use to blackmail someone, threatens to reveal victims information through embarrassing, social damaging unless money and property are met.

- **Acts of Terror**

Acts of terror or terrorism is an intentional act that may seriously damage a country by performing any act of destroying the fundamental political, economic or social structures of a country. The terrorist group may use violence, fear and pressure to the victims.

- **Kidnapping and Abduction**

Kidnapping is an act or the crime of abducting or carrying away a person by force usually accompanied by a ransom for money. A kidnapper usually an acquaintance or stranger who knows about a family's wealth or has a motive of sexual thought towards the victim. While abduction is the act of making a person go somewhere with you using violence or threat.

On the other hand, abduction is the use of deceit or force in order to take a person or a child away from their home or relatives. In abduction, the victim usually knows or has some sort of relation with the abductor. Most of the time, the abductor is not holding the victim for profit or any monetary gain.

Philippines: Anti-Terror Act faces top court challenges

The top most headlines among the intentional act that may lead to injuries are the act of terror. Last July 3, 2020 Pres. Rodrigo R. Duterte signed the law – the Anti-Terrorism Act of 2020 – will be a measure that seeks to give the country more teeth to curb terror threats and acts. What I Have Learned

Six categories of terrorism:

1. State terrorism – an act of terrorize the citizen by the state or government with the use of force or threat to achieve political goal without declaring war.
2. Bioterrorism - an intentional release of toxic biological agents to harm the citizen in the community. The attack will use viruses, bacteria and toxins that could kill thousands of people.
3. Cyberterrorism – an attack use computer system or telecommunications that may draw attention on terrorists' cause.
4. Ecoterrorism – an act to harm animal or the natural environment. Terrorist may destroy property to inflict economic damage on industries.
5. Nuclear terrorism – it is a terrorist tactic that may use nuclear materials.
6. Narcoterrorism – an act of drug traffickers to prevent government's effort in stopping drug trade. An assassination of government official who are anti-drug trafficking.
